General Information for Raleigh Summer Dressage I & II

DEFINITIONS/ELIGIBILITY:

- <u>JR/YR</u> Open to Juniors and Young Riders only; any rider is eligible until the end of the calendar year in which they reach the age of 21. Only riders ages 14-18 may ride FEI JR Tests. Only riders age 16-21 may ride FEI YR Tests. Only riders ages 12-16 may ride FEI Pony Tests.
- <u>AA</u> Open to Adult Amateurs only; riders must compete as adults from the beginning of the calendar year in which they reach the age of 22. Must hold current USEF Amateur card.
- <u>PE:</u> Riders must have a current USEF Dispensation Certificate, FEI PE Card, or USEF PE Classification Card to be eligible. All tests in Standard arena.
- <u>BLM</u> Colonel Bengt Ljungquist Memorial Championship qualifying class for 2011. Riders must be members of a participating organization at the time of the show to be eligible.
- <u>GAIG/USDF QUAL</u> Qualifying class for 2011 GAIG/USDF Regional Dressage Championships. *Declare qualifying ride on entry form.* Class fee plus additional \$10 fee *must be paid prior to start of the class.*
- <u>OPPORTUNITY CLASSES</u> No USEF/USDF memberships or Horse ID required for Opportunity classes if entered ONLY in Intro and/or Opportunity classes. Horses entered <u>only</u> in Opportunity classes are exempt from the \$15 USEF fee. However, horses entered in these classes are still subject to and must comply with all D&M rules and are subject to drug testing at the competition. Riders/horses at both competitions are permitted to cross-enter into other recognized classes at these shows.

AWARDS:

- Prize and five ribbons in each Dressage & DSHB class.
- Separate awards for AAs and/or Jr/Yrs in any Dressage Open class with four or more in either or combined divisions.
- Dressage High Score awards at Training-Fourth Levels, FEI Levels combined in each competition (ex. Equitation, Materiale, Freestyle & YH tests). All divisions (if offered) pinned separately. Exception: Open, GAIG/USDF Qualifying & BLM scored & pinned together.
- DSHB Championship classes receive only Champion and Reserve Championship ribbons.
- GAIG/USDFBC: The Champion & Reserve Champion in classes B13, B14, B15, B17 and B18 in each show will receive special ribbons and will qualify for the GAIG/USDF Breeders Championship East Coast Series Final at Dressage at Devon.
- ThinLine Dressage Trainers Award: Trainer plus min. two students. Awarded to team with highest average for both shows combined, but team may compete in either/both shows to be eligible. Sign-up in office by 10:00 am at first show competing. Additional details posted on sign-up form.
- USDF Dover Medal: Awarded to highest scoring eligible AA receiving at least 60% in Cl. #123 & #223.
- ThinLine Pro Am Team Challenge. One professional plus 2-3 AAs, JRs or Yrs. Awarded on Saturday.
- American Hanoverian Society: Special ribbon and trophy to the highest placing eligible Hanoverian in individual in-hand classes (IBC excluded) at each show. In order to be eligible, horse must be AHS registered and owner must be a current AHS member. Eligibility with AHS verified week prior to show.
- "Born in the USA" Award: Awarded to highest scoring (not highest placing) horse foaled in U.S. Eligibility determined by breeder's address on horse's registration papers. Winner will receive a special award. (One DSHB award for both shows combined.)
- High Score North Carolina Horse: Awarded to highest scoring (not highest placing) horse born in NC. Eligibility to be determined by breeder's address on horse's registration papers. Winner will receive a special award. (One DSHB award for both shows combined.)
- Other special awards to be announced in Official Program.

ENTRY INFORMATION:

- ALL FEES <u>MUST</u> BE PAID IN U.S. DOLLARS AND ENTRIES <u>MUST</u> BE <u>RECEIVED</u> BY CLOSING DATE! No processing fee for online entries.
- Make check payable to Rosinburg Events LLC and mail to secretary with entry and negative Coggins (for horses six months and older, and valid within 12 months and through both shows, if applicable).
- 2011 Entry form required. Entry form must be properly signed with original signatures; an adult (18 or older) must sign for JR riders and on trainer blank.
- USEF and USDF membership numbers and horse registration numbers must be provided where required. Photocopied signatures not permitted. *Unless exempt:* Must provide verification of (1) 2011 USEF "competing" membership for rider, handler, owner, trainer, and coach or pay Non-Member fee; (2) 2011 USDF membership verification for rider (PM or GM) and owner (PM, GM or BM), or copy of nonmember ID card and pay Non-Member fee; and (3) USEF Recording, USDF Lifetime Registration or USDF HID #. Owners of horses without USDF registration or HID MUST complete application, submit breed registry papers (if horse is registered) and pay \$25 USDF HID fee upon arrival at competition in order to participate (except IBC and exempt Dressage classes).
- Adult Amateur entries must provide verification of their USEF Amateur status or submit, at least one hour prior to class, a USEF amateur certification application with \$30 USEF amateur non-member certification fee.
- Pony Rider, Junior and Young Rider entries must include birth date on entry form.
- Proof of membership must be included with entry form. Please provide the USEF/USDF Master Verification (www.eqverification.org) although membership cards or photocopies of cards are still acceptable. Failure to provide proof of USEF and/or USDF membership will result in competitor being charged non-member fees.
- Non-U.S. citizen participants must send proof, in English, of current membership in good standing from their own NF, a photocopy of their 2011 USEF membership card, or must pay the USEF non-member fee.
- Post entries accepted with Late Fee, if scheduling permits, or placed on wait list to fill scratches.
- Non-negotiable checks void entry and incur a \$30.00 charge. Entry will be placed on waiting list until a money order, certified check or cash is received.
- All horses entered in breeder's group class must list what group they are to be shown with (only one entry/group pays the fee).
- Trainers: Email your "Stable With" list and stall order to show sec'y at least seven days before show.
- Show office will be open: Noon—7pm Friday, 7am—7pm Saturday, 7am—1 hour after show ends on Sunday.

NON-COMPETING HORSES:

Must submit completed and signed Entry form to the Show Secretary, show proof of current Coggins, and pay \$25 N/C Horse fee plus \$15/25 Office fee. Parking or stabling fees are also required. USEF/USDF fees or Late fee NOT required. No N/C fee due for N/C mare with foal.

MEMBERSHIP/REGISTRATION REQUIREMENTS FOR GAIG/USDF QUALIFYING CLASSES

Riders must be current USDF Participating members & USEF members (Junior, Senior or Life) in good standing. Horses must be USDF registered and USEF recorded. Horses with only an HID are not eligible. Owners must be current USDF Participating or Business members & USEF members (Junior, Senior or Life) in good standing.

HANDLERS AND ASSISTANT HANDLERS IN DSHB CLASSES:

Handler: Any person who holds, walks or trots a horse while it is being judged in the in the competition area or ring for any In-Hand, Group or Championship class, except as noted below.

Assistant Handler: Any person, other than Handler, who holds or walks a horse in competition arena during a class, whether or not horse is being judged at the time. An Asst. Handler is permitted only for call-backs after In-Hand or Group classes, for Championships and for handling non-competing mares/foals which accompany another entry in the competition arena. Asst Handlers may not show a horse at the trot, (ex. for horses not being judged but accompanying a mare or foal being judged). If not USEF members, are exempted from the USEF N-M fee. All Handlers and Asst Handlers MUST sign original entry form or Handler/Assistant Handler Release (on website) prior to entering ring and MUST have wristbands.

MATERIALE CLASSES

Judged under saddle as a group at walk, trot and canter according to criteria listed on the "USDF Materiale Class" score sheet. Horses must be at least 36 months of age to participate.

REFUNDS:

No refunds after closing date or after the start of the competition for any reason, including in the event of cancellation of classes due to severe weather or other emergency. Refunds will be made before closing date less a \$25 fee.

ENTRY STATUS & TIMES:

- Acknowledgement of entry showing status will be emailed (or mailed for competitors without email address) to each competitor. Include LEGIBLE email address with your entry. Please check for errors and notify the secretary immediately.
- Official times posted by noon on Friday at show office. Unofficial times posted on website approximately one week before show.

STABLING:

Most stabling in Barn E. Permanent wood stalls w/doors approximately 10 x 10 feet square. Half in center aisle barns; half in shed-row with 10' overhang. \$30 per night for each additional night. Shavings available for purchase at show. Those wanting extra bedding at stalls upon arrival must preorder through Secretary at least 24 hours prior to arrival. Each entry MUST include stabling or parking fee. Upon arrival, an extra copy of the Coggins must be posted on the stall door of each horse for examination by NC State Veterinarian's office inspector.

ACCOMMODATIONS:

Host hotel is the **Ramada Inn/Blue Ridge** (Ph: 919/832-4100), located .6 miles from the Horse Complex in Raleigh, near intersection of Blue Ridge and Trinity Roads. MUST MENTION SHOW TO RECEIVE SPECIAL RATE of \$82.00/King and \$84.00/Double. On-site camper hookups available at \$25/night; includes water, 30 amp electrical and sewage. Camper fee is collected by Fairgrounds security personnel after arrival; do not send to Secretary.

DIRECTIONS:

From I-440 (Beltline) in Raleigh, take the Hillsborough St. (NC 54) exit toward Cary/Chapel Hill. Turn right at stoplight onto Blue Ridge Road. Take first left onto Trinity Road. Horse Complex is on the left. **Enter Gate H-4 (for stabling) or Gate H-5, next to the Backyard Bistro (day parking)** across from Carter-Finley Stadium. From I-40 west, take Wade Ave./Carter-Finley Stadium exit. Exit right on ramp to Edwards Mill Road and turn right, then (at light) turn left on Trinity Road. Horse Complex is on right.

HOSPITALITY:

Food on grounds (from start until end of classes) during show. Free competitor's party after show on Saturday, sponsored by Red Letter Farm and Karen Brame. Hot beverages and bagels each morning sponsored by Lisa Seger Insurance (Markel). Ice Cream Social on Sunday sponsored by Encore Sporthorse, Inc.

ARENAS:

Three outside 20 x 60 meter sand/crushed granite screenings all-weather competition arenas. Large all-weather sand/crushed granite screenings warmup rings. All dressage classes in 20 x 60 meter arenas. Lungeing permitted only in designated areas. All dressage competition rings and warmups have underlying tile drainage systems and all competition and warmup areas are enclosed in perimeter PVC fencing. All DSHB competition and warmup in 135' x 210' outdoor sand rings adjacent to stabling for DSHB horses. ALL riding, lungeing and exercise is permitted only in rings/areas designated by this competition.

THINLINE PRO-AM TEAM CHALLENGE:

- One Professional plus two three Adult Amateurs, Juniors and/or Young Riders make up a Pro-Am Team. Any level may be ridden; levels may be combined. The three highest scores will be averaged to find the Team Score from the Saturday rides of all Team Members. (Intro, MFS, Materiale, Young Horse Tests and DSE scores will not be included.) Team members (Professionals, Amateurs, Juniors and Young Riders) are considered as a horse/rider combination if a rider has more than one horse entered in the competition, he/she may ride on more than one team each team must have unique horse/rider combinations.
- Awards: Special prizes donated by ThinLine for all members of 1st through 3rd placing Teams. All team members must be present at the Awards Ceremony to receive prizes. Ceremony will take place at competitors' party immediately after show on Saturday afternoon.
- Entries: No GMO memberships required and NO EXTRA FEES! Teams must be named with all team members indicated by 9am Saturday. Competitors may indicate intention to compete on entry form or may sign up in show office.

OTHER:

- Management reserves the right to add, combine or divide classes, add or substitute judges, or make any changes required by circumstances.
- If a competitor NO SHOWS their first class of the day, they may be considered a SCRATCH for the remainder of the day at show management's discretion.
- DOGS MUST BE ON LEASHES or otherwise contained AT ALL TIMES WHILE ON SHOW GROUNDS (INCUDING IN STABLE AREAS). Owner may be fined. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. All pets must be leashed. Non-compliance may result in USEF penalties.
- If ponies are entered in FEI Pony Test(s) and in need of a USEF measurement card, an appointment for measuring MUST be made with show management prior to the show.
- All emergency numbers will be posted in the Secretary's office and near the pay phones.
- Veterinarian and farrier will be on call. EMT on grounds.
- Riders may substitute horses once they have entered only upon presentation of a Vet Certificate for the incapacitated horse, or a bill-of-sale, and only in classes in which the first horse was entered. The Secretary must be notified 24 hours before the class(es) take(s) place, and a new entry form must be completed.
- Anyone bringing non-competing horses must supply, prior to Closing Date, a current Coggins and a signed entry form before entering the show grounds.
- Numbers must be worn at all times when a horse is being exercised or ridden.
- Bridles MANDATORY on horses age two and over (USEF DR206.2)
- In accordance with GR1301.7: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
- Sharps containers are located in the center aisle of each barn. Per USEF rules, competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.

- All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents, or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events.

USEF Membership Statement (GR901.9)

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

U.S. Equestrian Federation, Inc. Entry Agreement

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition.

I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules.

I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered.

I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable -casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.



Breeding Show Class Procedures

The triangle measures approximately 30 meters on the long side and 22 meters on each of the short sides. When called by the Ringmaster, present your horse to the Judge at "A" for conformation judging. Upon direction, follow the procedure as diagrammed below:

- * Higher scoring horses may be asked to return to the ring for reevaluation at the end of a class.
- * Foals may NOT be shown loose.



- Stand Horse at "A" for conformation judging.
- Walk small triangle: A-B-C-ATrot large triangle: A-D-E-A
- Leave judging area promptly unless requested to do otherwise by the judge.

<u>ATTENTION COMPETITORS – NEW HEADGEAR RULE FOR DRESSAGE</u>

Effective March 1, 2011, for dressage: Anyone mounted on a horse must wear protective headgear except those riders age 18 and over while on horses that are competing only in FEI levels and tests at the Prix St. Georges level and above (including FEI Young Rider Tests, the USEF Developing Prix St. Georges Test and the USEF Brentina Cup Test).

ATTENTION COMPETITORS

Each competitor is responsible for supplying management with correct association numbers (USDF, USEF) for horse, owner, rider and trainer, before the day(s) of the competition. The scores of competitors who fail to supply correct numbers may not be counted toward national awards.



2011 Great American Insurance Group/USDF Regional Dressage Championships



A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year.

Please refer to the *USDF Competitor and Member Guide* for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying & Championships:Rider:

- Must be a USDF Participating* Member (PM) at the time qualifying scores are earned and at the time of the championships.
- Must be a USEF member (Junior Active, Senior Active, or Life) at the time the qualifying scores are earned and at the time of the championships.

Horse:

- Must be USDF Lifetime Registered (LTR) at the time qualifying scores are earned and at the time of the championships.
- Must be USEF (Annual or Lifetime) recorded at the time qualifying scores are earned and at the time of the championships.
- USDF horse registration and USEF horse/recording must be in the name(s) of the current owner(s) or lessee(s) of record.
- A horse is not required to have registry papers.

Owner:

- Must be a USDF member (PM* or Business Member (BM)) at the time the qualifying scores are earned and at the time of the championships.
- Must be a USEF member (Junior Active, Senior Active, or Life) at the time qualifying scores are earned and at the time of the championships.
- *PMs are USDF members who join USDF directly.

USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores

One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for levels through Grand Prix, in three divisions: open, adult amateur, and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

2011 USDF/Dover Saddlery Adult Amateur Medal Program

The USDF/Dover Saddlery Adult Amateur Medal Program is designed to specifically recognize and encourage adult amateurs riding at Second Level.

Awards

1. USDF/Dover Saddlery Medal Recipient

The eligible rider with the highest score of 60 percent or better in the designated Second Level Test Three class or applicable test of choice USDF/Dover Saddlery Adult Amateur Medal class at a participating competition will receive a handcrafted USDF/Dover Saddlery pewter medal and neck ribbon. Winners will receive a \$20 Dover Saddlery gift certificate for the first three USDF/Dover Saddlery Medals they win during the competition season.

- 2. USDF/Dover Saddlery National Merit Award
 - A USDF/Dover Saddlery National Merit Award will be awarded to riders winning three USDF/Dover Saddlery Medals in the same competition year.
- 3. Year-End Awards

The USDF/Dover Saddlery Medal National Champion and Reserve Champion are determined from the average of the top three winning ride scores during the competition year. The champion receives a \$1000 Dover Saddlery gift certificate and the reserve champion receives a \$500 Dover Saddlery gift certificate.

Rider Eligibility

To be eligible, a rider must meet the following criteria:

- 1. Rider must be a current USDF Participating Member or Group Member at the time of the competition.
- 2. Rider must be an adult amateur in accordance with Article GR1306 of the USEF rules and be designated with USEF as an adult amateur as of the competition date.



<u>USDF Membership Benefits:</u> USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Competitor & Member Guide* or the USDF Web site at www.usdf.org.

<u>Membership Requirements for USEF-licensed/USDF-recognized Competitions:</u> Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or

owner/lessee, must have either a USDF Group Membership, Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF NM fee. (Note: USDF business members can own horses but cannot compete as riders with their USDF BM.) Individuals cannot compete at a USEF-licensed/USDF-recognized competition with a USDF Education Membership.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or
 dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions
 (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, Pas de Deux, Quadrille, FEI ParaEquestrian classes, are exempt
 from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy and
 opportunity classes. For foreign-owned horses competing in a CDI, USDF accepts copies of the horse identification pages from an FEI passport in lieu of
 a USDF HID or LHR number.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
 identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$75), 5-years (\$300), or life (\$1,500). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$60). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan*/USDF Year-End Awards, Great American Insurance Group/USDF Breeders' Championship Series Finals and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$200) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Education Membership (e-Membership): A membership issued to an individual directly by USDF. This online education only membership expires 12 months after the date joined. This membership type does NOT allow an individual to compete at a USEF-licensed/USDF-recognized competition.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$25 and a USDF NM form per competition that must be collected by the show secretary and submitted to USDF along with the USDF Report of Fees document and the \$5 affidavit fee if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF member there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF Web site.

Horse Identification (HID) Number: A one-time tracking number for horses (\$25). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes or Great American Insurance Group/USDF Breeders' Championship Series Finals. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$70. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$95) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete at Great American Insurance Group/USDF Breeders' Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date received by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 125 independent organizations throughout the United States with a membership in excess of 33,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

2011 Great American Insurance Group/USDF Breeders' Championship (USDFBC) Series Rules

The USEF Rulebook Chapter Dressage, Subchapter DR-2, contains the Dressage Sport Horse Breeding (DSHB) class rules. The rulebook is available on line at www.usef.org. All recent rule changes in the on-line rulebook are noted in RED.

A. Applying For and Scheduling Qualifier and Final Events

- The USDFBC series is scheduled on a calendar year basis (January 1-December 31).
- A series must have a minimum of three qualifying events in order to hold a series final. All shows in the series, including qualifier classes held in conjunction with the series final, are qualifying events.
- 3. The final event of each series is often the last USEF-licensed/USDF-recognized dressage competition holding DSHB classes *scheduled* in a particular geographical area of the United States as of July 1 of the year prior to the series final year. However, a series final may also be held at either a separate dressage or DSHB show, which does not offer other DSHB classes, and is not a USDFBC qualifying event. Host sites of series finals will be designated on or about August 1 of the year prior to the series final year.
- 4. The official USDFBC host site application form for qualifiers and series finals will be available from the USDF office by June 15, prior to the start of the next competition year. USEF- licensed/USDF-recognized-dressage competitions interested in hosting a final for a series must submit a completed USDFBC event application form and contract to the USDF office by July 1 of the year prior to the series final to request consideration for hosting the series final.
- All applications for a series final will be considered on a 'case by case' basis.
- 6. A series final will be considered "definite" when at least three qualifying events have registered with USDF to participate in the series for the year. If it meets the minimum requirements, a series final will be considered "tentative" until at least three events have registered for the series.
- 7. In case two or more qualified events in the same series wish to host the series final, the regional director(s) of the region(s) with qualifying events in the series will select the host site of the series final, after consultation with the chair of the USDF Sport Horse Committee and the USDF Sport Horse Committee liaison. Priority for the final will be given to (1) the date of event, which must be after all qualifying events are normally scheduled, and ideally, between August 1 and October 1 of the series final year, (2) the most prestigious DSHB show, or USDF Regional Dressage Championships in the geographical area, and (3) location and accessibility to competitors, and (4) experience of the competition management with DSHB competitions.
- All USEF-licensed/USDF-recognized dressage competitions with DSHB classes scheduled prior to the series final in the same calendar year and geographical area are eligible to participate in their USDFBC series final. Dressage

- competitions with DSHB classes scheduled after the series final in their area are not eligible to participate in the USDFBC program, and will not be qualifying events or the next year's series final.
- 9. Only one USDFBC series, or part of a series, may be held in any particular geographical area in the same calendar year. The boundaries of a "geographical area" will be determined by USDF (in consultation with regional directors and the chair of the USDF Sport Horse Committee), will include cluster(s) of DSHB shows, and may combine regions or cross regional boundaries. However, a maximum of two USDFBC series will be scheduled in the same USDF region in the same calendar year.
- 10. If a USDFBC series does not have at least three qualifying events recognized by USDF by June 1 of the series final year, the final will not be held.

B. Advertising and Promotion

- 1. In order to receive full promotional benefits from USDF, qualifying and final events must be approved at least six months prior to the competition.
- Qualifiers and final events must be approved by USDF each year *before* advertising that they are participating as qualifying or final events in the USDFBC program.

C. Prizes

- Prizes will be awarded during the finals competition award ceremonies.
- 2. Prizes and/or other awards may be withheld by USDF to series winners if the following information is not provided to USDF or show management by required deadlines: name of owner; name, age and sex of horse; and if known, the breed of horse, sire, dam, dam sire, and breeder.

D. Rules Regarding Contracts and Recognition

- Qualifying and final events must be USEF-licensed/USDFrecognized Dressage competitions and all classes must be conducted under USEF rules.
- 2. USDFBC event application, contract and rules for the upcoming competition year will be available to show managers by July 1 of the year prior to each USDFBC competition year.
- 3. Rule changes and requirements will be fully approved and publicized by July 1 of the year prior to each USDFBC competition year.
- 4. Changes of rules, requirements, or contract obligations for competition management (and/or competitors, if applicable) are not permitted after August 1 of the year prior to the start of the USDFBC competition year, except when changed by the USEF and/or USDF Executive Board.
- 5. USDFBC rules and procedures must be listed in the official prize list for the event, and must be available sufficiently in advance to all potential competitors, or the event may be in violation of USEF rules.
- 6. For qualifying events whose dates fall after the closing date for their series final event, the results must be emailed or faxed to USDF within 24 hours of completion of the

qualifying event. USDF will verify those horses who have qualified with the series final event secretary.

E. Horse Registration and Membership Requirements

- All horses entered in any USDF Breeders' Championship Series qualifying class must have either a USDF Life Registration (LHR) or USDF Horse Identification Number (HID), and submit identification information. A copy of breed registry papers (if available) must be submitted directly to USDF. Any horse participating in the series final classes must have a LHR with USDF. The HID fee will apply toward the LHR fee.
- Owner is not required to be a USDF member for qualifying events; however, owner must have a current USDF Participating Membership (PM) or Business Membership (BM) to compete at the series final class.
- 3. No USDF membership is required for the Handler.
- 4. Horses participating in USDFBC qualifying or final events are not required to be registered with any studbook, but "if a horse is registered with any breed organization, the name of the breed, sire, dam, dam sire and breeder must be given on the entry blank. For unregistered horses competing in DSHB classes, the information is strongly recommended, if available." (GR 907.1)
- 5. It is strongly recommended that horses not registered with a breed registry be listed as "unregistered".
- It is the responsibility of the horse owner to ensure that their USDF membership and USDF horse registration are correct and current.

F. Requirements for USDFBC Series Qualifying Events

- Classes must be offered and judged according to USEF DR 209
- All divisions must offer Sport Horse Prospect In-Hand and Breeding Stock In-Hand classes.
- 3. A separate championship class must be held for all divisions even those that have only one class or one horse in the division. For example if there is only one class of mares, the top two mares from that class would then be shown in the championship class. If there is only one stallion in the one stallion class that stallion would then show again in the championship class.
- 4. Each qualifying event must offer a **Current Year Foal Championship** class. This class is a USDFBC series qualifying class. This class must be held and judged (i.e. reevaluated at the walk and the trot).

The current year foal championship class, at qualifying events, must be open to first and second place winners of Sport Horse Prospect In Hand classes for all horses of current calendar year, as listed below. First and second place (and third if desired) fillies and colts/geldings of current year will compete against each other in the same class. (Organizers have the option of including third placed winners in championship classes)

Current Year Foal championship:

Fillies of current calendar year Colts/Geldings of current calendar year

5. Each qualifying event must offer a **Filly Championship** class and a **Colt/Gelding Championship** class. These classes are USDFBC series qualifying classes. These classes must be held and judged (i.e. re-evaluated at the walk and the

The filly and colt/gelding championship classes must be open to first and second placed winners of Sport Horse Prospect In Hand classes for all horses, as listed below.

(Organizers have the option of including third placed winners in championship classes.)

Filly championship:
Yearling Fillies
Two-year old Fillies
Three-year old Fillies

Colt/gelding championship:
Yearling Colts/Geldings
Two-year old Colts/Geldings
Three-year old Colts/Geldings

The champion and reserve champion filly and the champion and reserve champion colt/gelding are eligible to compete in their respective USDFBC series final class. A third place horse in each championship class must be named as well.

6. Each qualifying event must offer a Mare Championship class and a Stallion Championship class. These championship classes are USDFBC series qualifying classes. Mare and Stallion Championship classes must be open to first and second placed winners of Breeding Stock In Hand classes for horses age four years old and over, as listed below. (Organizers have the option of including third placed winners in championship classes.)

Mare championship:

Mare classes may be divided by age, competition and/or breeding status, as in the following example:

- Four-vear old and older maiden mares never bred
- Four-year old and older yeld mares-never bred or not currently bred or nursing
- Four-year old and older broodmares In foal or currently nursing-(mare only to be judged).
- For details on determining breeding status for competition purposes, please refer to USEF Rule 203.16.

Stallion championship:

Stallion classes may be divided by age, competition and/or breeding status, as in the following example:

- Four-year old and older stallions showing only in hand
- Four-year old and older stallions showing also under saddle

The champion and reserve champion mare and the champion and reserve champion stallion are eligible to compete in their respective USDFBC series final class. A third place horse in each championship class must be named as well.

- 7. Age/sex eligibility is determined as follows:
 - Fillies, colts and geldings three years of age or under may show ONLY as sport horse prospects, not in breeding stock classes/categories.
 - b) Mares and stallions age four and over may show ONLY in breeding stock classes/categories.
 Note: Two and three-year olds are ONLY eligible to compete in the filly or colt championships. They are NOT eligible for the mare or stallion championships.
 - c) Geldings of any age may NOT show in breeding stock classes/categories. Geldings age three and under may show ONLY in sport horse classes/categories.
- 8. Score sheets: Age group classes must be judged using the appropriate scoring categories and percentages. Sport horses MUST be evaluated on the (yellow) USDF Dressage Sport Horse Prospect In Hand score sheets and breeding stock MUST be evaluated on the (pink) USDF Dressage Sport Horse Breeding Stock score sheets.
- 9. Horses in all USDFBC Series qualifying classes must be evaluated according to USEF DR210.5.7.
- 10. During the same or separate awards ceremonies, the current year foal champion and reserve, the filly champion and reserve, the colt/gelding champion and reserve, the mare

champion and reserve, and the stallion champion and reserve, must be named USDFBC series qualifying champions and reserve champions for the show. A third place horse in each championship class must be named as well.

Announcements must identify sponsors and horses' breeding information.

- 11. Each of the ten qualifying horses must be presented with a qualifier ribbon. These ribbons will be supplied to the show by USDF. Only the champion and reserve champion will receive the qualifier ribbons, even if they have previously qualified. The third place horse in the qualifier championship class will not receive a qualifier neck sash. The qualifier ribbons for champion and reserve champion are identical.
- 12. All champions and reserve champions (ten qualifying horses from each competition) will be eligible to compete in the finals. In the event that a champion and/or reserve have already qualified for the final, the third-placed horse from the pertinent qualifying class will be eligible to compete in the final. Competition management is required to have judges place qualifying classes to three places. In addition, any other horse receiving a 77% or better in its age/sex class will be eligible to compete in the final (Effective, 2009 competition year)
- A list of qualified horses is maintained, by series, on the USDF website.
- 14. Horses must qualify in the series in which they enter the final. Exception: Horses that have qualified for a series final which is either not scheduled or is cancelled may participate in the final of any other USDFBC series in the same calendar year, without having to re-qualify for that series final. Owners of horses that have qualified for a final which is not held, may enter another series final, but must indicate which series they qualified at on their entry form.
- 15. Horses may compete in qualifying events in any series, but if qualified for more than one series final, they may participate in only one final class.
- 16. If there is a change of ownership of the horse, the new owner(s) may choose to participate in the series final where they reside, regardless of where the horse qualified, provided that the new owner contacts the USDF office and initiates the change at least 30 days prior to the new Series Final date.

G. Conduct of Finals Classes at the Breeders Series Championship Final

- At least two judges (see USEF DR 202) must officiate in each series final class. Each judge will evaluate each entry independently, and scribes must be provided for each judge. Winners will be determined by the average of all judges' scores. The highest scoring horses will be declared champions and the second highest will be declared reserve champions.
- 2. Ties in USDFBC Finals classes must remain unbroken.
- 3. There are five championship classes in the USDFBC Series Finals. Current year foal champions and reserves from each qualifying event will compete together in the USDFBC current year foal final class. Filly champions and reserves from each qualifying event will compete together in the USDFBC filly final class. Colt/gelding champions and reserves from each qualifying event will compete together in the USDFBC colt/gelding final class. Mare champions and reserves from each qualifying event will compete together in the USDFBC mare final class. Stallion champions and reserves from each

- qualifying event will compete together in the USDFBC stallion final class.
- 4. A grand champion and reserve grand champion current year foal, a grand champion and reserve grand champion filly, a grand champion and reserve grand champion colt/gelding, a grand champion and reserve grand champion mare, and a grand champion and reserve grand champion stallion will be named at each series final event. Grand champions will receive awards and prizes provided by USDF. Third through sixth placed horses in final classes will receive ribbons provided by USDF. After the final event, special certificates will be available from USDF via the website to owners of all horses that competed in USDFBC series final classes.
- 5. USDF reserves the right to change, alter, or retract any placings and/or prizes for up to 60 days after the last day of the championship if an error or violation is discovered, after which no changes will be made.
- 6. Horses must be shown individually on the triangle at the walk and trot, and standing for conformation. Each horse must be evaluated in the same manner. Callbacks are permitted. If horses may be recalled, the prize list or program must state that this procedure will be used. (USEF DR 209.1.c)
- 7. Horses in the current year foal final class, filly final class and the colt/gelding final class MUST be evaluated using the (yellow) USDF Dressage Sport Horse Prospect In Hand score sheets. Horses in the mare final class and the stallion final class MUST be evaluated using the (pink) USDF Dressage Sport Horse Breeding Stock score sheets.
- 8. When USDFBC series qualifying classes are held at the same event as series final classes, management must collect USDF Lifetime Horse Registration and/or Participating or Business Memberships applications and fees for eligible entries that wish to participate in the series final classes and submit these applications and fees to the USDF office within 24 hours of the series final classes with competition results.
- 9. Series final events must agree to allow late entries in the series final classes for horses that qualified for the Series final event after the official closing date.

H. Conduct and Competition Standards for Qualifying and Final Events

- DSHB competitions are not permitted to exclude horses from competing in an event that have previously qualified for a USDFBC series final. Such exclusion is not permitted by USEF rules, and results from the event may not be counted for USDF DSHB HOY awards.
- Neither foals nor horses of any other age may be shown loose.
- 3. Note the following clarification on "stallion": No geldings may compete in the USDFBC classes for stallions even if they are gelded after qualifying for the finals and are breeding via frozen semen.

I. Licensed Officials

- According to USEF DR 202.1 a competition with a
 Federation Licensed Dressage Sport Horse Breeding division
 must have a Federation licensed Dressage Sport Horse
 breeding judge and a Federation licensed dressage technical
 delegate. Guest Cards to judge DSHB classes are granted
 only to currently licensed foreign FEI Dressage Judges and
 approved foreign breeding experts (See USEF GR1011).
- Shows must apply to USEF for guest cards at least 21 days prior to the competition.
- Hunter Breeding judges or USEF judges with other licenses or in other disciplines are NOT permitted to judge DSHB classes.
