Please join us for the **Raleigh Spring Dressage** show on **May 14-15, 2022** on the Hunt Horse Complex on the North Carolina State Fairgrounds in Raleigh.

This show will be held in the main coliseum and other rings at the Hunt Horse Complex. Indoor as well as mobile vendors, including vendor supplied trailers or tents, can be accommodated at this event.

Several of our sponsors have exclusive vendor rights at this and other Rosinburg Events competitions. We cannot accept any tack/riding apparel shops, or insurance companies as vendors. In addition, the facility may limit and must pre-approve all food or beverage vendors. However, businesses that sell equestrian gifts and other specialties or services are welcome to attend.

Vendors must furnish Rosinburg Events, LLC with a Certificate of Insurance as evidence that Worker's Compensation Insurance (if applicable) and Public Liability Insurance is in force during the show. In addition, a photocopy of your North Carolina State Certificate of Registration, which serves as evidence that you have met the sales and use tax registration requirements for that jurisdiction and that you are authorized to collect and remit tax as required by law.

Please note that indoor vendors are REQUIRED to ensure face coverings are worn and social distancing is maintained by all unvaccinated staff and visitors to your business at all times. By submitting the contract and payment, you are agreeing to these conditions from the time of arrival to departure from the grounds.

When your contract is returned, **with full payment**, you will receive confirmation for your vendor space. Trade Fair spaces will NOT be reserved until the contract and fees are received by the show.
